*We invite you to be a part of the Sixth Annual Hot Air Balloon Festival in Talbot County. We are expanding to a **two day festival - Friday-Saturday**.*

All activities will be aimed toward young children and those young at heart. Activities include handmade crafts, retail and food vendors and hot air balloon activities including flights, tethers and walkabout balloon. Live entertainment! All vendors and events will be outside. Events are weather permitting. Friday and Saturday evening activities will culminate with up to 15 balloons participating in a Balloon Glow at dusk. Friday and Saturday: Gates open Noon and festival runs until 9 PM. All vendors/crafters have option to open early but are required to be open Noon-9PM.

PARKING: Two (2) Temporary Parking Passes will be provided at check in. All vendor/crafter vehicles must be moved from display area to vendor parking lot before 11:30AM.

Craft/Commercial/Food Vendors Guidelines

NOTICE 1: We have 5 LuLaroe vendors signed up and cannot accept additional

Exhibit space will fill quickly and space is limited. Applications will be placed on a first come, first-serve as space permits. All spaces are outside. There is no rain date. We expect to exceed our attendance over last year. Here are your options

CRAFT VENDOR: 10X10 Exhibit - \$150 or 10X20 Exhibit - \$200

COMMERCIAL VENDOR: 10X10 Exhibit – \$225 or 10X20 Exhibit - \$300

FOOD VENDOR: 10X20 space -- \$200 + 10% of Gross Sales

TENT/BOOTH INSTALLATION: May begin as early as 8 AM on August 4 and must be set up and vehicles removed by 11:30AM. Festival is held rain or shine.

TENT, Tables & Chairs: Vendors must provide their own

Booth Dismantling will occur starting at 9PM on Aug 6 or Sunday morning

Booth Location: Details will be provided upon arrival

STORAGE SPACE: No extra storage space will be provided

ELECTRICITY: Vendors must provide their own **VERY QUIET** generator. Noisy generators will not be allowed to be close to other vendors.

Food Vendor information: *Food Vendors must complete and forward Application to Operate a Temporary Food Service Facility to the Talbot County Health Department <http://www.chesapeakebayballoonandwinefestival.com/vendors/tempfoodpermit.pdf> must be adhered to during the Festival. Food vendors must submit a complete menu for approval during the application process. Any changes to proposed menu after acceptance must be approved by the Event Organizer. Must apply before July 16, 2017.*
